

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2026 Gu Achi District Budget Amendment No. 2)

RESOLUTION NO. 26-251

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2026 Gu Achi District Budget in the amount of \$4,735,610.33 was
13 authorized by Gu Achi District Resolution No. 0525-187 and approved by
14 Legislative Council Resolution No. 25-210 and subsequently amended by
15 Resolution No. 26-160 in the amount of \$5,373,205.73; and

16 **WHEREAS,** by Gu Achi District Council Resolution No. 0726-090, the Gu Achi District has
17 authorized and submitted for review and approval its FY 2026 Gu Achi District
18 Budget Amendment No. 2, which is incorporated by this reference, and which
19 will adjust operational and/or personnel line items; and

20 **WHEREAS,** the FY 2026 Gu Achi District Budget Amendment No. 2 will not change the
21 original budget amount of \$5,373,205.73; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2026 Gu Achi District
23 Budget Amendment No. 2 and recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY 2026 Gu Achi District Budget Amendment No. 2 in the amount of
26 \$5,373,205.73, effective October 1, 2025, and which will not change the original
27 budget amount of \$5,373,205.73.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2026 Gu Achi
29 District Budget as amended shall be managed and expended in accordance with
30 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the
31 Nation's laws, provided that any amendments or modifications shall be
32 authorized under District Council resolution and submitted for prior approval
33 by the Tohono O'odham Legislative Council.

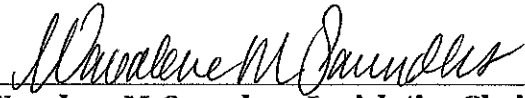
