

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Department of Information & Technology Coronavirus
Capital Project Budget)

RESOLUTION NO. 26-253

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham ("Nation") received funding from the United States**
8 **American Rescue Plan Act ("Recovery Funds") established by the American**
9 **Rescue Plan Act of 2021 ("ARP Act"); and**

10 **WHEREAS, the Department of Information & Technology has prepared and submitted for**
11 **review and approval it's FY 2026 Coronavirus Capital Project Budget which is**
12 **incorporated by this reference, in the amount of \$189,324.36 to be funded by the**
13 **United States Department of Treasury American Rescue Plan Recovery Fund**
14 **and;**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2026 Department of**
16 **Information & Technology Coronavirus Capital Project Budget and recommend**
17 **its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2026 Department of Information & Technology Coronavirus Capital Project**
20 **Budget effective October 1, 2025 through December 30, 2026 in the amount of**
21 **\$189,324.36 which shall be funded by the United States Department of Treasury**
22 **American Rescue Plan Recovery Fund.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
24 **O'odham Nation chairperson or any designated official is authorized to**
25 **administer and expend the FY 2026 Department of Information & Technology**
26 **Coronavirus Capital Project Budget, provided that any amendments or**
27 **modifications shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**

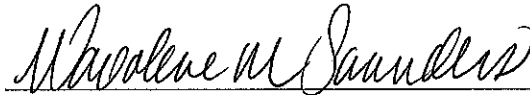

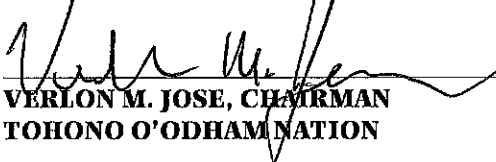
