Whereas, the Finance Committee of the Papago Council has determined that sufficient funds are available for increasing the per diem of delegates and officers attending council meetings for the remainder of the current fiscal year, now, therefore,

Be it resolved by the Papago Council, that we hereby authorize and request the Superintendent of Sells Agency to pay the various delegates and officers attending meetings of the Papago Council from November 1, 1937 to June 30, 1938 an amount equal to the sum listed opposite the name of the district represented by each officer and delegate as follows:
