

RESOLUTION
OF THE COUNCIL
THE PAPAGO COUNCIL

No. 19

Whereas, the Papago Council on December 4, 1937 by vote of 16 in

favor and none opposed, authorized the sale of trapping permits at \$10.00 each per season; and

Whereas, through an oversight, the action of the Council was not covered by an appropriate resolution and presented for review by the Secretary of the Interior as provided in Article V, Section 3, Paragraph E of the Papago Constitution; and

Whereas, it is the desire of the Papago Council to authorize the sale of hunting and trapping permits of the form and in the manner as has been the custom in the past, now, therefore,

Be it resolved by the Papago Council, that we hereby authorize the sale of trapping permits at \$10.00 each and hunting permits at \$10.00 each, said permits to require the purchasers, thereof, to abide by all Federal and State laws regarding hunting and trapping seasons, bag limits, etc., and to abide by all Federal laws and regulations of the Secretary of the Interior applicable to the Papago Reservation; said permits to cover hunting and trapping on the Papago Reservation only and to be issued by the Secretary of the Papago Council and approved by the Superintendent or officer in charge of the Sells Agency in the name of the Papago Tribe, and the proceeds from the sale, thereof, to be deposited in the Individual Indian Money Account of the Treasurer of the Papago Tribe with the Sells Agency; and we hereby approve the sale of all hunting and trapping permits issued heretofore; this resolution

to remain in force and effect until repealed by act of the Council.
