

RESOLUTION OF
THE PAPAGO COUNCIL

No. 110

Resolved by the Papago Council, that we hereby adopt the following budget for the fiscal year ending June 30, 1941.

BE IT FURTHER RESOLVED that the Secretary-Treasurer of the Papago Council in addition to performing the combined duties of Secretary of the Papago Council and Treasurer of the Papago Council as prescribed by Sections 3 and 4 of Article 1 of the By-laws of the Papago Tribe, shall also perform the duties of Clerk of the Sells Court of Indian Offenses and Clerk of the Papago Loan Board; and

BE IT FURTHER RESOLVED, that we hereby respectfully request the Commissioner of Indian Affairs to allot the sum of \$1,678.00 from the fund "Proceeds of Papago Indian Reservation, Arizona, Rentals, etc., (Tribal Councils, 1941)" to the Superintendent of Sells Agency as soon after July 1, 1940 as may be practicable; and

BE IT FURTHER RESOLVED, that we hereby authorize and request the Superintendent of the Sells Agency, or other Officer in Charge, to pay to the order of the Secretary-Treasurer of the Papago Council, the sum of \$2,806.00 from the fund, "I. I. M. Acct. No. P-84, Contributed Fund, Papago Tribe" for deposit under the same conditions as those of the previous fiscal year.
