

RESOLUTION
OF
THE PAPAGO COUNCIL

RES. NO. 319

WHEREAS, The position of Caretaker of the Papago Tribal Community Building will become vacant on July 1 by the resignation of the incumbent, Jose C. Narcho, and

WHEREAS, The position of Jailer of the Sells Jail is now vacant because of the current lack of Agency funds, and

NOW, THEREFORE, Be it resolved by the Papago Council that the position of Caretaker-Jailer be created, carrying a salary of \$100.00 per month to be paid upon the certification of the Tribal Secretary & Treasurer, one-half from Fund PT-4, Papago Tribe, Salaries of Tribal Employees and one-half from fund PT-8 Papago Tribe, Court funds,

PROVIDED, That the Caretaker-Jailer shall be responsible to the Tribal Secretary & Treasurer for the proper cleaning and maintenance of the Tribal Community Building; shall be responsible to the Court Clerk for the proper care of the Tribal Jail and Court Room and for the feeding and safekeeping of the prisoners; shall be deputized as a Tribal Policeman; and shall, under the direction of the Chief of Police, assist when called upon in the enforcement of Law and Order.

PROVIDED FURTHER, That any time worked by the Caretaker-Jailer on Law and Order enforcement beyond the usual 40-hour week be paid for from the fund PT-8, Papago Tribe, Court Funds at the rate of eighty-six cents (.86) per hour upon certification by the Chief of Police to the Secretary & Treasurer that such work was necessary and authorized,

PROVIDED FINALLY, That Lorentine Joaquin be appointed to the position of Caretaker-Jailer, to fill the position for the two-year period beginning July 1, 1947 and ending June 30, 1949, unless sooner terminated by the Papago Council.

The foregoing resolution was on June 6, 1947, duly enacted by a vote of 15 for and 0 against, by the Papago Council, pursuant to authority vested in it by Section 3 (a) and (b), Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934, (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of Sells Agency, subject to its rescission by the Secretary of the Interior, pursuant to Section 6, Article V of the Constitution and By-Laws of the Papago Tribe.
