

RESOLUTION
OF THE
PAPAGO COUNCIL

RES. NO. 374

BE IT RESOLVED BY THE PAPAGO COUNCIL, That the sum of \$17,300.00 be appropriated from the General Fund of the Papago Tribe, Acct. PT-1, for the ordinary expenses of the Papago Council for the fiscal Year 1949, to be transferred to the accounts listed below in the amounts set forth, and to be expended as authorized therein, on and after July 1, 1948.

PROVIDED, That at the end of the Fiscal Year 1949 any unobligated balances in any of the below-listed budget accounts shall revert to the General Fund PT-1.

PT-2	For travel expenses, per diem, and lodging allowances of delegates and officers of the Papago Council in attending regular and special meetings of the Council, whether or not there be a quorum, to be expended under authorization of the Secretary & Treasurer of the Papago Council - - - - -	Amended by Res. 395 \$3,500.00
PT-3	For stationery, office supplies, and equipment, telephone telegraph tolls, postage, etc., tribal truck operation, and maintenance to be expended under the authorization of the Secretary & Treasurer - - - - -	\$1,500.00
PT-4	For salaries of council employees, including special security taxes, lump sum payments, and promotions, to be expended under authorization of the Secretary & Treasurer - - - - -	6,300.00
PT-5	For travel expense, per diem, and lodging allowances of Council committees and Officers of the Papago Council in attending committee meetings, conferences, and such meetings other than Tribal Council meetings as it may be necessary for them to attend in the performance of their authorized duties, to be expended under the authorization of the Sec. & Treasurer.	3,000.00
PT-6	For maintenance, repairs, and improvements to the Tribal Community Building, to be expended under the authorization of the Secretary & Treasurer - - - - -	500.00
PT-7	For miscellaneous purposes not included in the above accounts, to be expended only under resolution of the Papago Council. -	2,500.00

BE IT FURTHER RESOLVED, That the above appropriation be adopted as the budget of the Papago Council for the Fiscal Year 1949.

The foregoing resolution was on June 4, 1948 duly enacted by the Papago Council by a vote of 13 for and 0 against, pursuant to authority vested in it by Sec. 3 (a), Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Sec. 16 of the Act of June 18, 1934, (48 Stat. 984). Said resolution is effective as of the date of its approval by the Superintendent of Papago Agency, and is subject to the rescission by the Secretary of the Interior pursuant to Sec. 6, Article V, of the Constitution and By-Laws of the Papago Tribe.
