WHEREAS, Ordinance No. 14 of the Papago Council requires the approval of the Council of the issuance of Tribal business licenses, and

WHEREAS, The Traders Committee of the Papago Council has considered the applications for peddlers licenses and has made recommendations to the Council,

(48 Stat. 934). Said resolution is effective as of the date of its approval by the Superintendent of Papago Agency, and is subject to the rescission by the Secretary of the Interior, pursuant to Sec. 6, Article V of the Constitution and By-Laws of the Papago Tribe.
