

RESOLUTION  
OF  
THE PAPAGO COUNCIL

No. 410

WHEREAS, the Plan of Operation of the Papago Tribal Herd Enterprise is not specific regarding cash deposits for bulls obtained from the Tribal Herd, and

WHEREAS, it has been the custom in the past to make cash refunds where bulls have been returned without a bull exchange being made, now

THEREFORE, be it resolved by the Papago Council that Section IV, of the approved Plan of Operation for the Papago Tribal Herd Enterprise, be revised to read as follows:

THE PAPAGO TRIBAL HERD ENTERPRISE SHALL ENTER INTO BULL LOAN AGREEMENTS WITH INDIVIDUAL, OR GROUPS OF, PAPAGOS SECURING THE SERVICES OF BULLS FROM THE PAPAGO TRIBAL HERD. SAID AGREEMENT TO PROVIDE THAT THE BORROWER SHALL DEPOSIT IN THE PAPAGO TRIBAL HERD ACCOUNT THE AMOUNT SPECIFIED IN THE BULL LOAN AGREEMENT AS A GUARANTY FOR THE SAFE KEEPING, WELFARE AND RETURN OF THE ANIMAL OR ANIMALS DURING THE LIFE OF THE AGREEMENT. SUCH ANIMAL OR ANIMALS SHALL BE RETURNED FOR EXCHANGE IN GOOD CONDITION AT THE EXPIRATION OF THE AGREEMENT AND SHALL BE EXCHANGED FOR ANIMALS IN EQUAL NUMBERS WITHOUT PAYMENT OF ADDITIONAL DEPOSITS, OR THE ORIGINAL DEPOSITS SHALL BE REFUNDED IN FULL WHERE EXCHANGE IS NOT MADE IN KIND. SUCH BREEDING STOCK MAY FOR GOOD REASONS, ACCEPTABLE TO THE NATESICH DIVISION, PAPAGO AGENCY, BE RETURNED ANYTIME DURING THE LIFE OF THE AGREEMENT, WHEREUPON THE TRIBAL HERD ENTERPRISE SHALL REFUND THE FULL AMOUNT OF THE ORIGINAL DEPOSIT. ALL ANIMALS RETURNED FOR CASH REFUND SHALL BE IN MARKETABLE CONDITION IN ORDER TO QUALIFY FOR SUCH REFUND. WHEN MARKET VALUE HAS BEEN REDUCED BECAUSE OF THE NEGLECT ON THE PART OF THE BORROWER THE TRIBAL HERD ENTERPRISE WILL MAKE PROPER ADJUSTMENT IN THE REFUND.

PROVIDED FURTHER, THAT THE SECTION REGARDING CASH REFUNDS SHALL APPLY TO ALL BULL LOAN AGREEMENTS PREVIOUSLY MADE.

The foregoing resolution was on June 3, 1949, duly enacted by a vote of 16 for and 0 against, by the Papago Council, pursuant to authority vested in it by Sec. 2 (c), 3 (a), 3 (h), Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Sec. 16 of the act of June 18, 1934, (48 Stat. 984). Said resolution is effective as of the date of its approval by the Superintendent of Papago Agency, and is subject to the rescission by the Secretary of the Interior pursuant to Sec. 6, Article V, of the Constitution and by-laws of the Papago Tribe.
