

RESOLUTION
OF
THE PAPAGO COUNCIL

NO. 417

BE IT RESOLVED BY THE PAPAGO COUNCIL, That the sum of \$14,600 be appropriated from the General Fund of the Papago Tribe, Account PT-1, for the ordinary expenses of the Papago Council for the Fiscal Year 1950, to be transferred to the accounts listed below in the amounts set forth, and to be expended as authorized therein, on and after July 1, 1949.

PROVIDED, That at the end of the Fiscal Year 1950 any unobligated balance in any of the below-listed budget accounts shall revert to the General Fund PT-1.

PT-2 For travel expenses and pay allowances for delegates and officers of the Papago Council in attending regular and special meetings of the Council, whether or not there be a quorum, to be expended under authorization of the Secretary and Treasurer of the Papago Council. PROVIDED, That only mileage allowance be paid when there is no quorum. present. _____	\$2,500.00	
PT-3 For stationary, office supplies, and equipment, telephone, telegraph tolls, postage, utilities to be expended under the authorization of the Secretary and Treasurer. _____	600.00	
PT-4 For salaries of Council employees, including Social/Taxes, lump sum payments and promotions to be expended under the authorization of the Secretary and Treasurer. _____	6,500.00	
PT-5 For travel expenses and pay allowances for Council Committees and officers of the Papago Council in attending committee meetings, conferences and such meetings other than Tribal Council meetings as it may be necessary for them to attend in the performance of their authorized duties, to be expended under the authorization of the Secretary and Treasurer. _____	1,500.00	
PT-5A For tribal truck operations, maintenance and repairs, to be expended under the authorization of the Secretary and Treasurer. _____	1,500.00	
PT-6 For maintenance, repairs and improvements to the Tribal Community Building, to be expended under the authorization of the Secretary and Treasurer. _____	500.00	
PT-7 For miscellaneous purposes not included in the above accounts, to be expended only under resolution of the Papago Council. _____	1,500.00	
TOTAL \$14,600.00		

BE IT FURTHER RESOLVED, That the above appropriation be adopted as the budget of the Papago Council for the Fiscal Year 1950.

The foregoing resolution was on July 8, 1949 duly enacted by the Papago Council by a vote 15 for and 0 against, pursuant to authority vested in it by Sec. 3(a), Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Sec. 16 of the Act of June 18, 1934, (48 Stat. 984). Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency, and is subject to the rescission by the Secretary of the Interior pursuant to Sec. 6, Article V, of the Constitution and By-Laws of the Papago Tribe.
