WHEREAS, The budget for the "Papago Tribe, Livestock Tax" Account PT-10 for the Fiscal Year 1950 has been presented by the Papago Livestock Board to the Papago Council with the recommendation that it be approved,

THEY THEREFORE, BY IT RESOLVED By the Papago Council that we authorize the expenditure from the Fund PT-10, Papago Tribe, Livestock Tax, of the amount budgeted and authorize the Secretary and Treasurer of the Papago Council to sign vouchers from this fund for the amount and purposes called for in the following budget:




Provided, That the unobligated balance in account PT-10, as of June 30, 1949 less the amount of the above budget be transferred to the General Fund Account PT-1.

The foregoing resolution was on July 8, 1949, duly enacted by a vote of 14 for and 0 against, by the Papago Council, pursuant to authority vested in it by Sec. 3 (a) of Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Sec. 16 of the Act of June 18, 1934, (48 Stat. 984). Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency, and is subject to the rescission by the Secretary of the Interior pursuant to Sec. 6, Article V, of the Constitution and By-Laws of the Papago Tribe.


