

RESOLUTION
OF
THE PAPAGO COUNCIL

NO. 429

WHEREAS, The Papago Council on May 20, 1949, by Resolution No. 409 appropriated three hundred fifty-eight dollars and sixty-three cents (\$358.63) deposited in Account Papago Tribe, Soldier's Memorial, PT-19 and future deposits made therein, for the erection of the Soldier's Memorial, and

WHEREAS, The Papago Council further resolved by Resolution No. 409 that the Secretary and Treasurer of the Papago Council shall authorize all payments from this fund for the purchase of supplies, freight, transportation, labor, and any and all other costs incurred in connection with the project, and

WHEREAS, Resolution No. 409 finally provides that the Papago Council may, if it deems necessary, appropriate money from its General Fund, PT-1, in an amount sufficient to complete the erection project, and

WHEREAS, On August 5, 1949, The Papago Veterans Association submitted their application to the Papago Council for a loan of one thousand dollars (\$1,000.00) with which to complete the erection of the memorial to the Papago War Dead and veterans of World War II, and

WHEREAS, The Papago Council has a great desire to assist the Papago Veterans Association to a successful completion of the proposed memorial,

THEREFORE, Be It Resolved by the Papago Council that the Superintendent of the Papago Agency be requested to transfer the sum of one thousand dollars (\$1,000.00) from PT-1, Papago Tribe, General Fund to PT-19, Papago Tribe, Soldier's Memorial for use by the Papago Veterans Association in the erection of the memorial.

PROVIDED: That this action of the Papago Council be not construed as authorizing and approving a loan, but as an outright contribution to the erection of the memorial, and

PROVIDED FURTHER: That any unobligated balance from the contribution shall revert to PT-1, Papago Tribe, General Fund.

The foregoing resolution was on August 5, 1949 duly enacted by a vote of 15 for and 0 against, by the Papago Council, pursuant to authority vested in it by Sec. 3 (a) of Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Sec. 16 of the Act of June 18, 1934, (48 Stat. 984). Said resolution is effective as of the date of its approval by the Superintendent of Papago Agency, and is subject to the rescission by the Secretary of the Interior pursuant to Sec. 6, Article V of the Constitution and By-laws of the Papago Tribe.
