RESOLUTION CF THE PAPAGO COUNCIL

WHIREAS, Lorentine Joaquin, Tribal Caretaker and Jailer, has submitted his resignation to the Papago Council, making it effective whenever the Papago Council can replace him,

THEREFORE, BE IT RESOLVED, By the Papago Council that Ramon Eackett of Sells District be appointed to the position of Caretaker and Jailer to serve out the unexpired two-year term of Lorentine Joaquin, which began on July 1, 1949 and will end on June 30, 1951, unless sooner terminated by the Council,

BE IT FURTHER RESOLVED, That the Caretaker and Jailer be paid at the rate of \$125.00 per month upon certification by the Tribal Secretary and Treasurer, one-half from Fund FT-4, Salaries of Tribal Employees, and one-half from Fund FT-8, Papago Tribe, Court Fund.

FROVIDED, That the Caretaker and Jailer, shall be responsible to the Tribal Secretary and Treasurer, for the proper cleaning and maintenance of the Tribal Community Building; shall be responsible to the Court Clerk for the proper care of the Tribal Jail and Court Room and for the feeding and safe-keeping of the prisoners; shall be deputized as a Tribal Policeman; and shall under the direction of the Chief of Police assist when called upon in the enforcement of Law and Order,

PROVIDED FURTHER, That any time worked by the Caretaker and Jailer, beyond the "usual"402hour week'be paid for from the Fund FT-8, Papago Tribe, Court Fund at the rate of eighty-six cents (.86) per hour upon certification by the Chief of Police or the Chairman of the Papago Council to the Secretary and Treasurer that such work was necessary and authorized,

FROVIDED FINALLY, That the resignation of Lorentine Joaquin and the appointment of Human Eackett shall become effective October 1, 1949.

The foregoing resolution was on September 23, 1949, duly enacted by a vote of 9 for and 7 against, by the Papago Council, pursuant to authority vested in it by Sec. 3 (a), (b), of Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Sec. 16 of the Act of June 18, 1934, (48 Stat. 964). Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency, and is subject to the rescission by the Secretary of the Interior pursuant to Sec. 6, Article V of the Constitution and By-Laws of the Papago Tribe.
