

RESOLUTION
OF
THE PAPAGO COUNCIL

Res. No. 673

WHEREAS: The Papago Council on August 1, 1952 authorized the filing of an application for a loan from the Revolving Credit Fund of the Indian Bureau up to the amount of \$40,000.00 for the purpose of establishing a Tribal Store Enterprise; and

WHEREAS: Upon receipt of the approval on the loan from the Revolving Credit Fund of the Bureau of Indian Affairs the Papago Council approved a Plan of Operation for the Papago Tribal Store Enterprise therein providing that the Papago Tribal Store Enterprise shall be operated in accordance with the attached Plan of Operation on the Tribe's own authority and responsibility, and further providing that the Plan of Operation may be amended as experience with the plan necessitates it; and

WHEREAS: In accordance with the Plan of Operation for the Papago Tribal Store Enterprise, the Sutherland Trading Post at Pisinemo Village and the Covered Wells Trading Post at Covered Wells Village have been purchased; and

WHEREAS: Of the total amount of \$6,187.00, the appraisal made on the Covered Wells Trading Post, payment in the amount of \$4,903.00 was made to Mr. A. R. Jameson, Jr. for the store buildings at Covered Wells by U. S. Treasurer Check No. 23,635 dated December 31, 1952, leaving a balance to be paid on the appraised value for the furniture and fixtures, of \$1,284.00; and

WHEREAS: In accordance with the agreement made between the Papago Tribe and Mr. A. R. Jameson, Jr. the payment on the appraised value of the furniture and fixtures amounting to \$1,284.00, for the Inventory and Accounts Receivable was to be made by the Papago Tribal Store Enterprise by check, which payment consisting of \$2,466.13 was made to Mr. A. R. Jameson, Jr. by Mr. A. D. Powers, Manager, Papago Tribal Store Enterprise by Check No. 1 dated January 2, 1953, this making a total payment for the fiscal assets of the Covered Wells Trading Post, the Inventory and Accounts Receivable in the total amount of \$7,369.13; and

WHEREAS: Of the total amount of \$9,790.50, the appraisal made on the Sutherland Trading Post, payment in the amount of \$6,823.00 was made to Mr. C. K. Sutherland for the store buildings at Pisinemo Village by U. S. Treasurer Check No. 23,634 dated December 31, 1952, leaving a balance of \$2,967.50 to be paid on the appraised value of the furniture and fixtures; and

WHEREAS: In accordance with the agreement made between the Papago Tribe and Mr. C. K. Sutherland the payment on the appraised value of the furniture and fixtures amounting to \$2,967.50 and for the Inventory and Accounts Receivable was to be made by the Papago Tribal Store Enterprise by check; and

WHEREAS: Upon completion of the inventory for the Sutherland Trading Post it was discovered that the value of the Inventory and the Accounts

Receivable amounting to \$13,220.82 had been greatly under estimated and therefore the amounts incorporated in the Plan of Operation of the Papago Tribal Store Enterprise for the purchase of the Sutherland Trading Post were much too low so that the initial advance of \$25,000.00 from the revolving credit fund on the Papago Tribe's loan Contract No. 14-20-454-1, is not sufficient to cover the cost of the Sutherland Trading Post, Covered Wells Trading Post, the Inventories, and Accounts Receivable which total \$30,300.45;

THEREFORE BE IT RESOLVED BY THE PAPAGO COUNCIL: That the sum of \$5,800.00 be appropriated from Account PT-10, Papago Tribe, Tax Collection from Livestock Sales, for the purpose of supplementing the funds of the Papago Tribal Store Enterprise for payment of the remaining balance on the furnitures and fixtures, the Inventory and the Accounts Receivable for the Sutherland Trading Post at Pisinemo Village;

PROVIDED: That a check shall be drawn made payable to the Papago Tribal Store Enterprise for deposit in the account of the Papago Tribal Store Enterprise in the Valley National Bank, Tucson, Arizona; and

PROVIDED FURTHER: That Account PT-10, Papago Tribe, Tax Collection from Livestock Sales, shall be reimbursed the \$5,800.00 by the Papago Tribal Store Enterprise upon receipt of the additional authorized advances granted the Papago Tribe on Loan Contract No. 14-20-454-1 from the Revolving Credit Fund of the Indian Bureau.

The foregoing resolution was on January 9, 1953, duly enacted by a vote of 20 for and 0 against by the Papago Council pursuant to authority vested in it by Sec. 3 (a) of Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936 and approved by the Secretary of the Interior on January 6, 1937, pursuant to Sec. 16 of the Act of June 18, 1934, (48 Stat. 984). Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency, and is subject to the rescission by the Secretary of the Interior, pursuant to Sec. 6, Article V of the Constitution and By-Laws of the Papago Tribe.
