

RESOLUTION
OF
THE TRIBAL OPERATIONS - THE PAPAGO COUNCIL.

WHEREAS: The Papago Livestock Board has submitted to the Papago Council for consideration its proposed Tribal Hard Herd budget for the Fiscal Year 1954, and

WHEREAS: The Papago Council finds that during the Fiscal Year 1953 the Tribal Hard Herd not only exceeded its budget of over one thousand dollars, but its expenditures exceeded \$16,000.00 or over ten thousand dollars,

THEREFORE BE IT RESOLVED BY THE PAPAGO COUNCIL THAT a budget of \$16,000.00 be approved for the Papago Tribal Hard Herd for the Fiscal Year 1954, and the Papago Tribal Manager is specifically enjoined to keep his expenditures within this figure,

BE IT FURTHER RESOLVED: That the Superintendent of the Papago Agency be requested and authorized to transfer immediately the sum of \$16,000.00 from Account PT-9, Papago Tribal Herd, to Account PT-8X, Papago Tribal Herd Operation, and

BE IT FURTHER RESOLVED: That all receipts from herd operations for Fiscal Year 1954 be deposited in Account PT-8X, Papago Tribal Hard, and

BE IT FURTHER RESOLVED: That at the end of Fiscal Year 1954 all unexpended funds in Account PT-8X, Papago Tribal Hard, Operations, shall revert to Account PT-9, Papago Tribal Herd, and

BE IT FINALLY RESOLVED: That the Secretary and Treasurer be hereby authorized to sign vouchers for expenditures from Account PT-90 in the amounts and for the purposes called for in the following approved budget,

PROVIDED: That expenditures from Item 12, "Land Improvements and PMA Work," may be made only upon Resolutions of the Papago Livestock Board:

The foregoing resolution was on July 24, 1953, duly enacted by a vote of 15 for and 0 against by the Papago Council pursuant to authority vested in it by Sec. 3 (a) of Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936 and approved by the Secretary of the Interior on January 6, 1937, pursuant to Sec. 16 of the Act of June 13, 1934 (48 Stat. 984). Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to the rescission by the Secretary of the Interior, pursuant to Sec. 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
