

RESOLUTION  
OF THE  
PAPAGO COUNCIL

RES. NO. 1385

WHEREAS, at the meeting of the Papago Council on August 7, 1964, the Council passed Tribal Resolution No. 1378, amending the contract between the Papago Tribe and Royal D. Marks, Tribal Land Claim Attorney, to provide that the limitation to be paid to the said Royal D. Marks under the contract be increased from \$10,000.00 to \$15,000.00 and that of this amount of \$15,000.00 the additional sum of \$5,000.00 be paid to Dr. Bernard L. Fontana for his services as anthropologist and as witness at the trial of the Tribal Land Claim Case in Washington, D.C., and

WHEREAS, this increase in the limitation of the contract means that an additional amount of \$5,000.00 is to be paid under the contract, and there is no provision in the 1965 fiscal year Tribal Budget for such increase, and

WHEREAS, the Papago Council desires that this additional amount of \$5,000.00 be paid to the said Dr. Bernard L. Fontana,


NOW, THEREFORE, LET IT BE RESOLVED, that the Papago Council hereby orders and directs that the 1965 fiscal year Papago Tribal Budget, approved and adopted by the Papago Council on June 5, 1964, under Tribal Resolution No. 1361, be and the same hereby is amended by adding the sum of \$5,000.00 to the Item named "Provision for expense in connection with land claim, etc.", increasing the amount of such Item to \$11,000.00 in said Budget.

LET IT BE FURTHER RESOLVED, that the Papago Council hereby re-approves and re-adopts in its entirety the balance of the 1965 fiscal year Budget of the Papago Tribe, and hereby orders, directs and authorizes the Treasurer of the Papago Tribe to sign purchase orders and vouchers in the said additional amount of \$5,000.00 against the properly designated account.

The foregoing Resolution was duly enacted by the Papago Council on September 4, 1964, with a vote of 19 for, 0 against, and 3 not voting, during a meeting at which a quorum was present, pursuant to authority vested in the Council by Section 3 (a) of Article V of the Constitution and By-Laws of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (Stat. 984), pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of this date of its approval by the Superintendent of the Papago Agency and is subject to rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
