RESOLUTION OF THE PAPAGO COUNCIL

RES. NO.1386

WHEREAS, for the past two years the present policy of assigning special policemen for patrol duty at dances and feasts throughout the Papago Reservation has not worked out satisfactorily, and

WHEREAS, special policemen assigned to their posts have failed to make their appearance at the required time or else were not in proper physical condition when they did appear for duty and when there has been trouble on various occasions they have failed to make necessary arrests, and

WHEREAS, it has been suggested that the Tribal Law and Order Department hire 22 part-time policemen to work at the said dances and feasts, two ment to be selected from the eleven Districts on the Reservation, three men to work at each dance or feast and to be paid \$10.00 per night, and

WHEREAS, out of the 22 men employed, four men would work each week/and in each of the four police districts to patrol with the regular Tribal policemen on night duty, working at approximately 80 dances and feast throughout the Reservation on a year-round basis and bringing the total cost thereof to \$4,480.00 per year.

NOW, THEREFORE, LET IT BE RESOLVED by the Papago Council that the Papago ribal Law and Order Department shall immediately hire 22 part-time policemen to do patrol work at various dances and feasts throughout the Papago Reservation, two men to be selected from each of the eleven Districts on the Reservation, three men to work at each dance or feast and each man to be paid \$10.00 per night.

LET IT BE FURTHER RESOLVED, that out of the 22 men employed, four men will work each week / and in each of the four police districts of the Reservation to patrol with the regular Tribal policemen on night duty, working at approximately 80 dances and feasts throughout the Reservation on a year-round basis, the total cost of hiring such men to be \$4,480.00 per year.

The foregoing Resolution was duly enacted by the Papago Council on September 4, 1964, with a vote of 18 for, 0 against, and 4 not voting, during a meeting at which a quorum was present, pursuant to authority vested in the Council by Section 3 (a) and Section 3 (b) of Article V of the Constitution and By-Laws of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (Stat. 984), pursuant to Section 16 of the Act. of June 18, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
