## RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 1390

WHEREAS, in the 1965 fiscal year Budget of the Papago Tribe under the Section entitled: "RODBO BOARD", repairs to the Rodeo grounds, including labor and material, is listed at the amount of \$415.00, and

WHEREAS, the papago Rodeo Beard has voted that certain and various repairs be made to the Rodeo Stadium at this time, including the painting of the old bleachers, installing panel on Judges Stand and buffer board around the fence of the Stadium, installing cable on top of pests, repairing gates and chute, installing sinks and drains in the concession booths, and

WHEREAS, the amount already budgeted for repairs in the current Budget is insufficient to pay for the work and materials.

NOW, THEREFORE LET IT BE RESOLVED, by the Papago Council that the sum of \$1,500.00 to allocated and set aside in order to perform the necessary work outlined above and that expenditures up to that amount be paid for labor and the purchase of materials, in addition to the amount of \$415.00 already budgeted for the purposes above set forth.

LET IT BE FURTHER RESOLVED, that the Papago Council hereby orders and directs that the 1965 fiscal year Papago Tribal Budget, approved and adopted by the Papago Council on June 5, 1964, under Tribal Resolution No. 1361, be and the same hereby is amended by adding the sum of \$1,500.00 to the Item named "RODEO BOARD-Repairs to Rodeo grounds-labor and material", increasing the amount of such Item to \$1,915.00 in said Budget.

LET IT BE STILL FURTHER RESOLVED, that the Papago Council hereby reapproves and re-adopts in its entirety the balance of the 1965 fiscal year Budget of the Papago Tribe, and hereby orders, directs and authorizes the Treasurer of the Papago Tribe to sign purchase orders and vouchers in the said additional amount of \$1,500.00 against the properly designated account.

The foregoing Resolution was duly enacted by the Papago Council on September 25, 1964, by a vote of 15 for, 0 against, and 6 not veting, during a meeting at which a quorum was present, pursuant to authority vested in the Council by Section 3 (a) of Article V of the Constitution and By-Laws of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (Stat. 984), pursuant to Section 16 of the Act. of June 18, 1934.

Said Resolution is effective as of the date of its approval by the Superintendent of the Papage Agency and is subject to rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
