RESOLUTION OF THE PAPAGO COUNCIL

Res. No. 1470

WHEREAS; The Papago Council, the Chairmen of the eleven (11) District Councils and other delegates representing organizations and groups within the Districts met in extended orientation sessions on June 17, 18, 30 and July 1, 1966 which were sponsored by the Papago Office of Economic Opportunity and the Indian Community Action Center at Arizona State University, and

WHEREAS; Intensive orientations were held on the Economic Opportunity Act of 1964, as amended, and the Community Action Program of the Papago Tribe during which Messions an overview of the Economic Opportunity Act and its objectives were discussed, and a review was given on the development of the Papago Community Action Program covering the period beginning September 2, 1964 to June 1966, and

WHEREAS; A thorough discussion was held on the new Community Action Program Proposals for the Program Year 1966-67 and the proposed reorganization of the Papago Community Action Program's organizational structure, and

WHEREAS; In accordance with the proposed reorganization plan it has been proposed that a Board of Directors be appointed for the Papago Office of Economic Opportunity and that it consist of one member from each of the eleven (11) Districts. This Board would replace the present Community Action Program Committee as the over-all policy making body and also make the body more representative.

THEREFORE, BE IT RESOLVED BY THE PAPAGO COUNCIL; That the following proposed components of the Papago Community Action Program, including, Conduct and Administration; Remedial Reading; Guidance and Counseling; Community Parent-Child Centers; and Pre-Schools be approved and forwarded to the Office of Economic Opportunity in Washington, D. C., and

BE IT FURTHER RESOLVED; That the reorganization plan as presented by the Director of the Community Action Program be approved and that the Districts be requested to submit their selections of persons for membership on the Board of Directors of the Papago Office of Economic Opportunity, and

BE IT FURTHER RESOLVED; That the proposed Community Development, Legal Services, and Leadership Training Programs be referred to the Districts for further discussion, and that action be taken on these proposed pro-

grams at the next meeting of the Papago Council.

The Foregoing Resolution was on July 1, 1966, duly enacted by a vote of -22 for and 0 against, by the Papago Council, pursuant to authority vested in it by Secs. 2 (a), (e), and (f) of Article V of the Constitution of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934, (48 Stat. 984).
