RESOLUTION OF THE PAPAGO TRIBAL COUNCIL.

RES. NO. 1499

WHEREAS, the U.S. Corps of Engineers on November 23, 1964, paid one-hundred thirty thousand dollars (\$130,000) to the Papago Tribe of Arizona for a Flowage Easement on the Gila Bend Indian Reservation, Arizona in accordance with Resolution No. 1095 of the Papago Tribal Council, and

WHEREAS, this one hundred thirty thousand dollars (\$130,000) was deposited in the Papago Agency Individual Indian Money Accounts, from November 23, 1964, until January 29, 1965, when it was deposited into the U.S. Treasury, and

whereas, Resolution No. 1095 of the Papago Tribal Council authorized a division of this one hundred thirty thousand dollars (\$130,000) one-half to the Gila Bend District and one-half to the Papago Tribal Council in accordance with provisions of the Papago Tribal Constitution, and

WHEREAS, Resolution 1457 of the Papago Tribal Council authoried the purchase of twenty (20) acres of land at a cost of fifteen thousand dollars (\$15,000) to be withdrawn from funds on deposit to the Papago Tribal Council with the Treasury of the United States, which was accomplished as of June 8, 1966,

NOW THEREFORE BE IT RESOLVED by the Papago Tribal Council

1. Fifty thousand dollars (\$50,000) be paid to the Gila Bend Dstrict from funds on deposit to the credit of the Papago Tribal Council in the U.S. Treasury as follows:

11/23/64 Deposited \$65,000 6/08/66 Land Purchase \$15,000 12/08/66 Balance \$50,000

2. That interest be paid to the Gila Bend District at the rate that it would have earned if it had been allowed to remain on deposit in the Papago Agency Individual Indian Money Accounts from funds on deposit to the credit of the Papago Tribal Council in the U.S. Treasury as follows:

Said Resolution is effetive as of the date of its approval by the Superintendent of the apago Agency and is subject to rescission by the Secretary of the interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
