

**RESOLUTION OF THE PAPAGO COUNCIL**

**RES. NO. 16-68**

**WHEREAS:** The Heads of the several Departments of the Papago Tribal Government prepared the Departmental and Board budgets, and

**WHEREAS:** The Budget Committee has reviewed these Departmental Budgets and grouped them into a total Budget For The Papago Tribe and has submitted it to The Papago Council for its consideration, and

**WHEREAS:** The Papago Council feels that the Department Heads and the Budget Committee have carefully considered the present and future needs of the Tribe, its income potential and other relevant factors and have therefore presented what it considers to be a reasonable budget, and

**WHEREAS:** The Papago Council recognizes that the proposed budget is a plan for the future use of Tribal income and that these plans may of necessity change as circumstances occur during the fiscal year and therefore reaffirms its right to amend the Budget to give effect to changed conditions,

**THEREFORE, BE IT RESOLVED BY THE PAPAGO COUNCIL,** That The 1969 Fiscal Year Budget of the Papago Tribe is hereby approved and adopted, as presented;

**PROVIDED;** That the Treasurer of The Papago Council is hereby authorized to approve expenditures in amounts not to exceed those in the approved Budget, and that the Treasurer is charged with the responsibility to keep The Papago Council aware of any conditions which may necessitate a change in the approved Budget, and that the Treasurer of The Papago Council is under no circumstances authorized to expend amounts in excess of the individual Department and Board Budgets without first securing the approval of The Papago Council for the budget amendment deemed necessary, and

**THEREFORE BE IT FINALLY RESOLVED:** That the Tribal monies derived from all income during Fiscal Year 1969 which will be deposited in the U. S. Treasury be made available immediately after receipt to finance operations of the program as recommended in the Budget and that such funds be hereby considered allotted Trust Funds subject to the withdrawal by the Tribal Treasurer upon proper execution of Standard Form 1034, including therein reference to this blanket resolution.

The foregoing Resolution was duly enacted by The Papago Council on June 21, 1968, with a vote of 20 for, 0 against, and 2 being absent, at a meeting at which a quorum was present, pursuant to authority vested in it by Section 3 (a) of Article V of the Constitution and By-Laws of The Papago Tribe, ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of

the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of The Papago Tribe.
