RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 1-76

WHEREAS, the North 1/2, SW 1/4, Section 10, T. 16 S, R 8 E. located in the Schuk Toak District on the Papago Indian Reservation 2 consisting of 80 acres, was deeded to the parents of Keith 3 Lummis in the late 1800's and was omitted from the Executive Order of 1917 creating that portion of the Papago 5 Indian Reservation; and WHEREAS, this property lies within the boundaries of Schuk Toak Dis-7 trict and contains a well which would be of beneficial use 8 to the District; and 10 WHEREAS, representatives of Mr. Lummis have offered to sell this property to the Papago Tribe for \$20,000.00; and 11 WHEREAS, the Superintendent of the Papago Agency and the Realty 12 13 Office of the Bureau of Indian Affairs have indicated that the BIA cannot purchase this property for the Tribe with-14 out a specific allocation of funds from Congress; and 15 WHEREAS, the Schuk Toak District Council passed a Resolution on the 16 17 13th day of December, 1975, (a copy of which is attached 18 hereto and made a part hereof) wherein they authorize the 19 Realty Office of the BIA to negotiate the purchase of said 20 80 acres at the best price possible but not to exceed 21 \$20,000.00, and to request that the Papago Tribe partici-22 pate in the purchase of said property by providing one-half 23 (1/2) of the purchase price at the time of purchase. 24 Schuk Toak District Council further stated that if the 25 Papago Tribal Council approved the purchase of said prop-26 erty by the Schuk Toak District but does not have suffi-27 cient funds to pay one-half (1/2) of the purchase price at 28 that time the District will consummate the contract pro-29 vided the Papago Tribe reimburses the District for one-half 30 (1/2) of the purchase price; and 31 WHEREAS, it is in the best interests of the Papago Tribe to purchase 32 said property.

NOW, THEREFORE, BE IT RESOLVED that the Papago Tribal Council does hereby join with the Schuk Toak District and authorizes 2 the Realty Office of the BIA to negotiate the purchase of 3 said 80 acres at the best price possible but not to exceed \$20,000.00; 5 BE IT FURTHER RESOLVED that the Papago Tribal Council will partici-6 pate in the purchase of said property by providing one-half 7 (1/2) of the purchase price at the time of purchase, or in 8 the event the funds are not available at the time of pur-9 chase, the Papago Tribe will reimburse the Schuk Toak Dis-10 trict for one-half (1/2) of the purchase price when suffi-11 cient funds are available. 13 The foregoing Resolution was duly enacted by the Papago Council on 14 the 15th day of January, 1976, at a meeting at which a quorum was 15 present with a vote of 689.5 for; 81.0 against; 63.5 not 16 voting; and 2 absent; pursuant to authority vested in the Papago 17 Council by Section 3 (a) and (h) of Article V of the Constitution 18 and By-laws of the Papago Tribe of Arizona ratified by the Tribe on 19 December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937 (48 Stat. 984) pursuant to Section 16 of the Act of June 18, 1934.
