

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 39-76

1 WHEREAS, pursuant to a direction of the Papago Council, Augustine Lopez, as Chair-
2 man of the Council, did appoint an Overall Economic Development Program
3 (OEDP) Committee charged with recommending to the Papago Council economic
4 development program priorities for the Papago Reservation, which Committee
5 consisted of the Vice-Chairman of the Papago Council in office, as stand-
6 ing Chairman of the Committee, and of the following members:

8 Vincent Manuel
9 Ricardo Manuel
Dave Jose; and

10 WHEREAS, the names of said appointees were submitted to and approved by the Papago
11 Council at its regular meeting on December 1, 1972; and

12 WHEREAS, the OEDP Committee, in accordance with its charge, did prepare an Overall
13 Economic Development Plan for the Papago Reservation dated December 1,
14 1973; and

15 WHEREAS, one member of the OEDP Committee, namely Dave Jose, has died and the
16 Committee has requested appointment of a replacement member; and

17 WHEREAS, the OEDP Committee has completed its annual review of the Overall Economic
18 Development Plan and has submitted its recommendations in form of the
19 attached 1976 List of Projects with a request that it be reviewed, the
20 projects be approved, and economic development priorities for the Papago
21 Reservation be set.

22 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby approve
23 the projects described in the attached list and recommends development
24 of said projects in the order of priority therein set out.

25 IT IS HEREBY FURTHER RESOLVED that the OEDP Committee is hereby directed to incor-
26 porate the aforementioned projects in the approved order of priority into
27 the annual revision of the Papago Tribe's Overall Economic Development
28 Program.

29 IT IS HEREBY FURTHER RESOLVED that the Chairman of the Papago Council is hereby
30 authorized and directed to appoint a replacement member of the Overall
31 Economic Development Committee.

Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is not subject to review by the Secretary of the Interior.
