WHEREAS, the Chukut Kuk District did by Council Resolution reserve and set over to the Papago Tribe, and to the supervision and control of the Papago Coun-2 cil, those arable lands situated in the southwestern portion of the 3 Chukut Kuk District known as Papago Farms consisting of approximately 4 3600 acres for the purpose of further subjugating and irrigating said 5 lands for farming and grazing; and 6 WHEREAS, the Papago Council believes it to be in the best interest of the Papago 7 Tribe that it immediately take over the operation and control of said 8 9 lands; and WHEREAS, a state of extreme emergency exists brought on by six years of continuous 10 drought which requires the immediate use and development of all possible 11 farm and livestock forage resources on the Papago Reservation. 12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby accept 13 supervision and control of the approximately 3600 acres of arable lands 14 in the Chukut Kuk District known as Papago Farms. 15 BE IT FURTHER RESOLVED that the Papago Council hereby requests Bureau of Indian 16 Affairs financial and technical assistance to further the subjugation and 17 irrigation of said land for the purpose of farming and grazing and in 18 order to permit drought stricken cattle on the Papago Reservation a chance 19 to survive the ravishes of the drought through a planned deferment and 20 21 rotation program on the Papago Reservation. The foregoing Resolution was duly enacted by the Papago Council on the 12th day of 22 August, 1976, at a meeting at which a quorum was present with a vote of 834.0 for; O against; O not voting; and I absent, pursuant to the authority vested in the Council by Section 2 (a) and (d) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona, ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of 23
