

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL



1 WHEREAS, Wesley and Margaret Pablo, enrolled members of Sells District and resi-
2 dents of Big Fields Village, are desirous of better housing and have
3 applied for financing through Farmers Home Administration; and
4 WHEREAS, a lot is needed to build a house on; and
5 WHEREAS, the Pablos appeared before the Sells District Council and requested a lot
6 described herein; and
7 WHEREAS, at their meeting of September 9, 1976 the Sells District Council did pass
8 Resolution No. _____ approving the assignment of said land to the Pablos
9 for use as a home site; and
10 WHEREAS, it is a Farmers Home Administration requirement that the Tribal Council
11 approve the assignment of said land to Mr. & Mrs. Pablo and also that the
12 Council authorize the Pablos to encumber the leasehold interest with a
13 Farmers Home Administration approved mortgage.
14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does accept, approve,
15 and affirm the Sells District Council Resolution No. _____.
16 BE IT FURTHER RESOLVED that pursuant to said resolution it does assign to Wesley &
17 Margaret Pablo that parcel of land lying within the Papago Reservation
18 and described as:
19 That parcel of land lying in the Papago Indian Reservation:
20 Beginning at Sta. 44+01.93 of Papago Route 24, the E. C. of
21 curve #8 as shown on sheet 16 of Project No. P. I. R. Consol.
22 4, Pima County, Arizona.
23 Thence along the tangent line having a bearing of S81°40'
24 08" E, a distance of 261.7 to a point on the tangent line;
25 Thence S80° 09' 18" E, a distance of 771.03 feet to a point;
26 Thence N09° 50' 42" E, a distance of 40 feet to the True
27 Point of Beginning;
28 Thence S80° 09' 18" E, a distance of 332.00 feet to a point;
29 Thence N52° 00' 42" E, a distance of 177.27 feet to a point;
30 Thence N09° 50' 42" E, a distance of 133.61 feet to a point;
31 Thence N80° 09' 18" W, a distance of 451.00 feet to a point;
32 Thence S09° 50' 42" W, a distance of 265.00 feet to the True
 Point of Beginning.
 Containing in all 2.56 acres; and


1 BE IT FURTHER RESOLVED that said assignment shall be for use as a homesite; and
2 BE IT FURTHER RESOLVED that it does authorize the Pablos to encumber the lease-
3 hold interest with a Farmers Home Administration approved mortgage; and
4 BE IT FURTHER RESOLVED that if the Pablos should default in payment on said mort-
5 gage that the Sells District of the Papago Tribe shall have first right
6 to assume said mortgage and/or to assign said mortgage to an eligible
7 Papago resident of the Sells District.


8 The foregoing Resolution was duly enacted by the Papago Council on the 8th day
9 of October, 1976, at a meeting at which a quorum was present with a vote of 834.0
10 for; 0 against; 0 not voting; and 2 absent; pursuant to authority
11 vested in the Papago Council, Article V, Section 2 (a), (c), (m) and Article VIII,
12 Section 3 (a) & (b) of the Constitution and By-laws of the Papago Tribe of Arizona
ratified by the Tribe on December 12, 1936, and approved by the Secretary of the
Interior on January 6, 1934 (48 Stat. 984). Said Resolution is effective as of
the date of its approval by the Superintendent of the Papago Agency and is not sub-
ject to review by the Secretary of the Interior.
