

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 18-78

1 WHEREAS, the Corps of Engineers had a lease covering 64 aerial photographic  
2 marker sites 100 feet by 100 feet square in the Sif Oidak District,  
3 and

4 WHEREAS, the lease expired on June 30, 1976, and the Corps of Engineers has  
5 requested an extension of the lease for five years ending March 31,  
6 1981, and

7 WHEREAS, the Corps of Engineers has offered to increase the rental payment  
8 from \$1,900.00 per year to \$2,560.00 per year based on an appraisal  
9 of the fair market rental value of the 64 sites, and

10 WHEREAS, the lease provides for the deletion of any sites which may conflict  
11 with mineral development of land surrounding the site by the District  
12 and the Tribe, and

13 WHEREAS, on July 13, 1977, the Sif Oidak District Council approved said lease  
14 and terms above stated.

15 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the decision of the  
16 Sif Oidak District be approved.

17 The foregoing Resolution was duly enacted by the Papago Council on the 11th  
18 day of April, 1978, at a meeting at which a quorum was present with a  
19 vote of 416.5 for; 286.5 against; 362  
20 not voting; and 1 absent; pursuant to authority vested in the  
21 Papago Council by Article V, Sections 2 (c) and (f) of the Constitution and  
22 By-laws of the Papago Tribe of Arizona, ratified by the Papago Tribe on  
23 December 12, 1936, and approved by the Secretary of the Interior on January 6,  
24 1937 (48 Stat. 984) pursuant to Section 16 of the Act of June 18, 1934. Said  
25 Resolution is effective as of the date of its approval by the Superintendent of  
26 the Papago Agency and is not subject to review by the Secretary of the Interior.
