

RESOLUTION OF THE PAPAGO COUNCIL

Res. No. 21-78

1 WHEREAS, Section 4 of Article III of the Constitution of the Papago Tribe, as  
2 amended, requires the Papago Council to select a Secretary from without  
3 its membership, to serve until replaced at the pleasure of the Council;  
4 and

5 WHEREAS, Section 3 of Article I of the By-Laws of the Papago Tribe defines the  
6 duties of the Secretary; and

7 WHEREAS, Mary Jane Jones has resigned as Secretary and it is mandatory to  
8 appoint a successor.

9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby appoint  
10 Mary Jane Narcho as Secretary of the Papago Council.

12 The foregoing Resolution was duly enacted by the Papago Council on the 5th.  
13 day of May, 1978, at a meeting at which a quorum was present with a vote  
14 of 993.5 for; 0 against; 71.5 not voting; and 3 absent,  
15 pursuant to the authority vested in the Council by Section 4 of Article III and  
16 Section 2 (e) of Article V of the Constitution and By-Laws of the Papago Tribe  
17 as amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
18 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the  
19 Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by  
20 the Secretary of Interior and is effective as of the date of its enactment by  
21 the Papago Council.


