

RESOLUTION OF PAPAGO COUNCIL

RESOLUTION No. 23-78

1 WHEREAS, the Papago Housing Authority was created to remedy unsafe and
2 unsanitary housing conditions on the Reservation, to alleviate the
3 acute shortage of decent, safe and sanitary dwellings for persons of
4 low income, and to provide employment opportunities in relation to
5 housing construction and;


6 WHEREAS, the Papago Housing Authority has been designated as the only Tribal
7 organization to deal with housing problems on the reservation and;

8 WHEREAS, other organizations and individuals on the reservation, including
9 Papago Construction and the Planning Department having been dealing
10 with housing construction;

11 NOW THEREFORE BE IT RESOLVED, that any and all housing construction and
12 rehabilitation for low income persons financed through any government
13 organization should be coordinated with the Papago Housing
14 Authority.

15 The foregoing Resolution was duly enacted by the Papago Council on the 5th.
16 day of May, 1978, at a meeting at which a quorum was present with a vote
17 of 631.5 for; 211 against; 222.5 not voting; and 3 absent,
18 pursuant to the authority vested in the Council by Section 3 of Article IV and
19 Section 3 (a) (h) of Article V of the Constitution and By-laws of the Papago
20 Tribe as amended, ratified by the Papago Tribe on December 12, 1937, pursuant
21 to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
22 effective as of the date of its approval by the Superintendent of the Papago
23 Agency and is subject to review by the Secretary of the Interior.
