11	Self Determination Act for the sum of (\$36,400 for the operation of the						
12	Children's Court as prescribed in the proposal submitted by the Children's						
13	Court.						
14	The foregoing Resolution was duly enacted by the Papago Council on May 24 ,1978						
15	at a meeting at which a quorum was present with a vote of 1065 for; 0 against

17	Council by Section 2 (a) of Article V of the constitution and By-laws of the						
18	Papago Tribe, as amended, ratified by the Tribe on December 12, 1936, and appro-						
19	ved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16						
20	of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to						
21	review by the Secretary of Interior.
