10	P.L. 93-638 Indian Self-Determination Act for the sum of \$12,500 to be						
11	used for payroll of the two clerk-typist positions in the Enrollment						
12	Office.						
13	The foregoing Resolution was duly enacted by the Papago Council on May 24, 1978,						
14	at a meeting at which a quorum was present with a vote of 968.0 for; 54.0 against						
15	0 not voting; and 2 absent; purusant to authority vested in the Papago						
16	Council by Section 2 (a) of Article V of the Constitution and By-laws of the						
17	Papago Tribe, as amended, ratified by the Tribe on December 12, 1936, and appro-						
18	ved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16						
19	of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to						
20	review by the Secretary of Interior.
