

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. No. 26-78

1 WHEREAS, the Bureau of Indian Affairs have funds available at the Papago Agency
2 in the sum of \$12,500; and

3 WHEREAS, these funds are for the purpose of Enrollment; and

4 WHEREAS, the Papago Tribe has two clerk-typist positions in the Enrollment Office
5 which are critically needed in the performance of the duties of the
6 Enrollment Program.

7 NOW, THEREFORE, BE IT RESOLVED that the Papago Tribal Council of Arizona author-
8 izes the Chairman or in his absence the Vice-Chairman and/or Treasurer
9 to negotiate a contract with the Bureau of Indian Affairs under the
10 P.L. 93-638 Indian Self-Determination Act for the sum of \$12,500 to be
11 used for payroll of the two clerk-typist positions in the Enrollment
12 Office.

13 The foregoing Resolution was duly enacted by the Papago Council on May 24, 1978,
14 at a meeting at which a quorum was present with a vote of 968.0 for; 54.0 against
15 0 not voting; and 2 absent; purusant to authority vested in the Papago
16 Council by Section 2 (a) of Article V of the Constitution and By-laws of the
17 Papago Tribe, as amended, ratified by the Tribe on December 12, 1936, and appro-
18 ved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16
19 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
20 review by the Secretary of Interior.
