

RESOLUTION OF PAPAGO COUNCIL  
(Removal of Cipriano Manuel from )  
(Board of Papago Housing Authority)

RES. NO. 32-78

WHEREAS, Cipriano Manuel was appointed by the Papago Council as a member of the Board of the Papago Housing Authority; and

WHEREAS, on May 5, 1978, the Board of Papago Housing Authority, in accordance with the provisions of the Ordinance of the Papago Tribe establishing the Papago Housing Authority, filed written notice with the Papago Council alleging specific charges that Cipriano Manuel had neglected his duties as a member of the Board of the Papago Housing Authority, and requesting that Cipriano Manuel be removed from the Board; and

WHEREAS, at its meeting on May 5, 1978, the Papago Council set the matter for hearing before the Council on May 17, 1978; and

WHEREAS, at the request of Cipriano Manuel such hearing was delayed until June 7, 1978; and


WHEREAS, the Papago Council has heard the charges brought against Cipriano Manuel, and upon hearing all the evidence presented by the Board of the Papago Housing Authority and by Cipriano Manuel, and their respective witnesses, the Papago Council is fully appraised of all of the facts and the law.

NOW, THEREFORE, THE PAPAGO COUNCIL DOES FIND that written notice of the specific charges brought against Cipriano Manuel was served upon him more than ten (10) days prior to this hearing on such charges and that, from the evidence and testimony presented at this hearing, Cipriano Manuel was in neglect of duty under Article IV, Sec. 4 (d) of the Papago Housing Authority Ordinance as a member of the Board of the Papago Housing Authority

THEREFORE, BE IT RESOLVED by the Papago Council that Cipriano Manuel is hereby removed from the Board of the Papago Housing Authority effective immediately.

The foregoing Resolution was duly enacted by the Papago Council on the 7th day of June, 1978, at a meeting at which a quorum was present with a vote of 689 for; 238 against; 138 not voting; and 2 absent, pursuant to the authority vested in the Council by Sections 2 (e), (f) and (m) of Article V of the Constitution and By-laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its enactment by the Papago Council.


