WHEREAS, the First Papago Southern Baptist Church was issued a ten-year Revocable Permit by the Papago Agency which expired on June 30, 1977, and

WHEREAS, the pastor of the First Papago Southern Baptist Church, has requested a renewal of the lease for a church site and related programs which will be set up at a later date,

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does accept, approve, and affirm the Sells, District Council Resolution.

The foregoing Resolution was duly enacted by the Papago Council July 7, 1978 at a meeting at which a quorum was present with a vote of 1015.5 for; 0 against; 49.5 not voting; and 3 absent, pursuant to the authority vested in the Papago Council by Section 1, Article V; and Section 3 (a) of Article VIII of the Constitution and By-Laws of the Papago Tribe, as amended, ratified by the Papago Tribe of December 12, 1936, pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is not subject to review by the Secretary of the Interior.
