

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 34-78

1 WHEREAS, On January 12, 1968, the Sells District Council granted a lease
2 to the First Papago Southern Baptist Church for a 4.41 acre site".
3 for such term as the law permits and upon the revocation of that
4 portion of federal reserve as is now or may hereinafter be
5 occupied by the Church ...", and

6 WHEREAS, the First Papago Southern Baptist Church was issued a ten-year
7 Revocable Permit by the Papago Agency which expired on June 30,
8 1977, and

9 WHEREAS, the pastor of the First Papago Southern Baptist Church, has
10 requested a renewal of the lease for a church site and related
11 programs which will be set up at a later date,

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does accept,
13 approve, and affirm the Sells, District Council Resolution.

14 The foregoing Resolution was duly enacted by the Papago Council July 7, 1978
15 at a meeting at which a quorum was present with a vote of 1015.5 for; 0
16 against; 49.5 not voting; and 3 absent, pursuant to the authority
17 vested in the Papago Council by Section 1, Article V; and Section 3 (a) of
18 Article VIII of the Constitution and By-Laws of the Papago Tribe, as
amended, ratified by the Papago Tribe of December 12, 1936, pursuant to
Section 16 of the Act of June 18, 1934. Said Resolution is effective as
of the date of its approval by the Superintendent of the Papago Agency
and is not subject to review by the Secretary of the Interior.
