

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 41-78

1 WHEREAS, the Papago Tribe of Arizona is committed to the economic
2 development of Papago Land and the improvement of economic
3 life for its people; and

4 WHEREAS, the Papago Council has authorized participation in the U.S.
5 Department of Commerce, Economic Development Administration
6 program by establishing an Overall Economic Development
7 Planning Committee and an EDA planning program; and

8 WHEREAS, it is the responsibility of the OEDP Committee to make an
9 Overall Economic Development Plan for the improvement of
10 conditions and to present a list of action projects for the
11 consideration and prioritization of the Papago Council.

12 NOW, THEREFORE, BE IT RESOLVED that the Papago Council hereby approves
13 the projects on the attached list for development in the
14 order presented for submission to the Economic Development
15 Administration.

16 The foregoing Resolution was duly enacted by the Papago Council on the
17 7 day of July 1978, at a meeting at which a quorum was present
18 with a vote of 1027 for; 0 against; 38 not voting; and
19 2 absent, pursuant to authority vested in the Papago Council by
20 Section 2 (f) of Article V of the Constitution and By-Laws of the
21 Papago Tribe of Arizona ratified by the Tribe on December 12, 1936,
and approved by the Secretary of the Interior on January 6, 1937,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
Said Resolution is not subject to review by the Secretary of Interior
and is effective as of the date of its enactment by the Papago Council.
