WHEREAS, the Papago Tribe of Arizona is committed to the economic development of Papago Land and the improvement of economic life for its people; and

WHEREAS, the Papago Council has authorized participation in the U.S. Department of Commerce, Economic Development Administration program by establishing an Overall Economic Development Planning Committee and an EDA planning program; and

WHEREAS, it is the responsibility of the OEDP Committee to make an Overall Economic Development Plan for the improvement of conditions and to present a list of action projects for the consideration and prioritization of the Papago Council.

NOW, THEREFORE, BE IT RESOLVED that the Papago Council hereby approves the projects on the attached list for development in the order presented for submission to the Economic Development Administration.

The foregoing Resolution was duly enacted by the Papago Council on the day of <u>July 1978</u>, at a meeting at which a quorum was present with a vote of 1027 for; 0 against; 38 not voting; and absent, pursuant to authority vested in the Papago Council by Section 2 (f) of Article V of the Constitution and By-Laws of the Papago Tribe of Arizona ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of Interior and is effective as of the date of its enactment by the Papago Council.
