15	on the 27 day of <u>July</u> , 1978, at a meeting at which a quoru
16	was present with a vote of 899.0 for; 85.5 against; 80.5
17	not voting; and $0$ absent, pursuant to the authority vested i
18	the Council by Section 3 (b) of Article V of the Constitution
19	and By-Laws of the Papago Tribe as amended, ratified by the
20	Papago Tribe on December 12, 1936, pursuant to Section 16 of
21	the act of June 18, 1934 (48 Stat. 984). Said Resolution is
22	effective as of the date of its approval by the Superintendent
23	of the Papago Agency and is subject to review by the Secretary
24	of the Interior.
