

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 45-78

1 WHEREAS, David and Merla Conde, enrolled members of Boboquivari
2 District and residents of Topawa Village, are desirous
3 of better housing and have applied for financing
4 through Farmers Home Administration (FHA); and

5 WHEREAS, a lot is needed to build a house on; and

6 WHEREAS, David and Merla Conde, appeared before the Boboquivari
7 District Council and requested a lot described herein;
8 and

9 WHEREAS, at their meeting of April 8, 1978, the Boboquivari
10 District Council did pass a Resolution approving the
11 assignment of said land to the Condes' for use as a
12 home site; and

13 WHEREAS, it is a Farmers Home Administration requirement that
14 the Tribal Council approve the assignment of said
15 land to Mr. & Mrs. Conde and also that the Council
16 authorize the Condes' to encumber the leasehold in-
17 terest with a Farmers Home Administration approved
18 mortgage.

19 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it
20 does accept, approve, and affirm the Boboquivari
21 District Council Resolution.

22 BE IT FURTHER RESOLVED that pursuant to said Resolution it
23 does assign David and Merla Conde that parcel of
24 land laying within the Papago Reservation and describ-
25 ed as:

26 TOPAWA PARCEL

27 All that part of unsurveyed Township 19 South,
28 Range 5 East, Gila and Salt River Base and Meridian
29 Village of Topawa, Papago Indian Reservation, Pima
30 County, Arizona, more particularly described as
31 follows:

32 Commencing at Station 461 + 58.40, a P.K. nail set

in the pavement on the centerline of Bureau of Indian Affairs, Route 19, Thence South 88°46' 31" West, a distance of 8971.34 feet to the TRUE POINT OF BEGINNING.

Thence North 88°24'40" West, a distance of 100.00 feet;

Thence North 01°35'20" East, a distance of 150.00 feet;

Thence South 88°24'40" East, a distance of 100.00 feet;

Thence South 01°35'20" West, a distance of 150.00 feet;

to the TRUE POINT OF BEGINNING.

Containing 0.34 acres, more or less.

BE IT FURTHER RESOLVED That said assignment shall be for use as a home site: and

BE IT FURTHER RESOLVED that it does authorize the Condessto encumber the leasehold interest with a Farmers Home Admisistration approved mortgage; and

BE IT FURTHER RESOLVED THAT if the Condes should default in payment on said morgage that the Boboquivari District of the Papago Tribe shall have first right to assume said mortgage and/or to assign said mortgage to an eligible Papago resident of the Boboquivari District.

The foregoing Resolution was duly enacted by the Papago Council on the 4 day of August, 1978, at a meeting at which a quorum was present with a vote of 1065.0 for; 0 against; 0 not voting; and 0 absent; pursuant to authroifty vested in the Papago Council, Article V, Section 2 (a) (c) & (m) and Article VIII, Section 3 (a) & (b) of the Constitution and By-laws of the Papago Tribe of Arizona ratified by the Tribe on December 12, 1936, and approved by the Secretary of
