

Resolution Of The Papago Tribal Council  
(Requesting IHS emergency funds for Whitehorse  
Pass village domestic water system)

RES. No. 54-78

1 WHEREAS, the well providing domestic water to the village of Whitehorse Pass  
2 is in jeopardy of going dry and has required that pumping be reduced  
3 to only one-half hour a day and the hauling of water from distant  
4 wells; and

5 WHEREAS, the loss of the only domestic well and of delivery of domestic water  
6 to the village of Whitehorse Pass creates a threat to the health and  
7 well being of the village.

8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby requests  
9 emergency funding from the Indian Health Service to provide the  
10 village of Whitehorse Pass with a satisfactory well field and/or  
11 domestic water delivery system.

12 The foregoing Resolution was duly enacted by the Papago Council on the 11  
13 day of October, 1978, at a meeting at which a quorum was present with a  
14 vote of 962 for; 0 against; 0 not voting; and 4 absent, pursuant to the  
15 authority vested in the Council by Section 2 (a) and (h) of Article V of the  
16 Constitution and By-laws of the Papago Tribe as amended, ratified by the Papago  
Tribe on December 12, 1936, and approved by the Secretary of the Interior on  
January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984). Said Resolution is not subject to review by the Secretary of Interior  
and is effective as of the date of its enactment by the Papago Council.
