

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 58

1 WHEREAS, the Papago Tribal Council, by Ordinance No. 2-78, voted
2 to distribute FIFTY THOUSAND DOLLARS, (\$50,000.00) of
3 mining income royalty to each district; and

4 WHEREAS, these funds are to be used at the discretion of the
5 individual district councils; and

6 WHEREAS, the Sells District Council by majority vote set budget
7 priorities for its District to come out of the
8 \$50,000.00 distribution. (See attached budget)

9 THEREFORE, BE IT RESOLVED that the Sells District Council
10 requests support and approval from the Papago Tribal
11 Council for its District budget; and

12 BE IT FURTHER RESOLVED that the District budget be authorized
13 to be paid out of the \$50,000.00 allotment

14 LET IT ALSO BE RESOLVED, that the Sells District Council will
15 use the funds only for the purposes stated.

16 The foregoing Resolution was duly enacted by the Papago Council
17 on the 3rd day of November, 1978, at a meeting at which a
18 quorum was present with a vote of 1065 for; 0 against;
19 0 not voting; and 1 absent, pursuant to the authority
20 vested in the Council by Section 2 (d) (h) (m) and Sec. 3 (a)
21 of Article V of the Constitution and By-laws of the Papago
22 Tribe as amended ratified by the Papago Tribe on December 12,
1936, and approved by the Secretary of the Interior on January
6, 1937, pursuant to Section 16 of the Act of June 18, 1934
(48 Stat. 984). Said Resolution is not subject to review by
the Secretary of Interior and is effective as of the date of
its enactment by the Papago Council.
