

1 WHEREAS, the Papago Agency has five buildings that are excess to its needs,
 2 and are identified as Building No. 55, Quarters No. 37, 38, 41,
 3 and 42, and

4 WHEREAS, various Departments of the Papago tribal government and individual
 5 employees are in need of either office space or living quarters,
 6 and

7 WHEREAS, the Papago Agency is willing to transfer the above mentioned
 8 buildings to the Papago Tribe for occupancy and maintenance,
 9 and


10 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that Building No. 55,
 11 Quarters No. 37, 38, 41, and 42 be transferred to the Papago Tribe for
 12 occupancy and maintenance as it is to the best interest of the Government
 13 and exercise of tribal self-determination for the Papago Tribe.


14 The foregoing Resolution was duly enacted by the Papago Council on 1st
 15 day of December, 1978, at a meeting at which a quorum was present with
 16 a vote of 827 for; 139 against; 99 not voting; and 0 absent;
 17 pursuant to authority vested in the Papago Council by Article V, Section 2,
 18 (a) and (f) of the Constitution and By-Laws of the Papago Tribe of Arizona
 ratified by the Tribe of December 12, 1936, pursuant to Section 16 of the
 Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of
 the date of its approval by the Superintendent of the Papago Agency and is
 not subject to review by the Secretary of the Interior.
