

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 63-78

1 WHEREAS, the Papago Tribe of Arizona is committed to the economic development
2 of Papago land and the improvement of economic life for its
3 people, and

4 WHEREAS, the Council has authorized participation in the United States
5 Department of Commerce, Economic Development Administration program
6 by establishing an Overall Economic Development Planning Committee
7 and an EDA Planning Program, and

8 WHEREAS, the EDA has authorized a Continuation Grant of \$30,000. to fund
9 the Papago Economic Development Planning Program for twelve (12)
10 months from November 1, 1978 through October 31, 1979.

11 NOW, THEREFORE, BE IT RESOLVED that the Papago Council authorizes the
12 application for these grant continuation funds.


13 The foregoing Resolution was duly enacted by the Papago Council on 1st
14 day of December, 1978, at a meeting at which a quorum was present with
15 a vote of 1031.4 for; 0 against; 0 not voting; and 1 absent;
16 pursuant to authority vested in the Papago Council, Section 2 (f) of Article
17 V of the Constitution and By-Laws of the Papago Tribe of Arizona ratified
18 by the Tribe on December 12, 1936, and approved by the Secretary of the
19 Interior on January 6, 1934, (4 Stat. 984). Said Resolution is effective
20 as of the date of its approval by the Superintendent of the Papago Agency
21 and is not subject to review by the Secretary of Interior.
