

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 6-80

1 WHEREAS, by Resolution No. 102-79 the Papago Council did direct the Chairman  
2 or Vice-Chairman of the Papago Council, the Director of Papago Con-  
3 struction, the Consultant, Mr. Richard Dolny and the Personnel  
4 Director to prepare a job description for the position of Consultant/  
5 Manager for Papago Construction; to advertise and interview applicants  
6 for such position; and to make recommendations to the Papago Council  
7 to fill the position of Consultant/Manager of Papago Construction;  
8 and

9 WHEREAS, two recommendations of applicants for such position have been submitt-  
10 ed to the Papago Council and the Council has interviewed such appli-  
11 cants;

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
13 selection and approve the employment of W.M. "Mickey" Lane as  
14 Consultant/Manager of Papago Construction and does hereby authorize and direct  
15 the Chairman or Vice-Chairman and the Secretary of the Papago Council to  
16 negotiate and execute an employment contract with W.M. "Mickey" Lane  
17 on behalf of the Papago Tribe and/or Papago Construction.

18 The foregoing Resolution was duly enacted by the Papago Council on the 12th  
19 day of February, 1980 at a meeting at which a quorum was present with a  
20 vote of 581 for; 295 against; 89 not voting; and 1  
21 absent, pursuant to the authority vested in the Council by Section 2 (3) and  
22 (f) of Article V of the Constitution and By-Laws of the Papago Tribe as amended,  
23 ratified by the Papago Tribe on December 12, 1936 and approved by the Secretary  
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June  
18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
Secretary of Interior and is effective as of the date of its enactment by the  
Papago Council.
