

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Concerning effect of Colville decision)

RES. NO. 101-80

1 WHEREAS, the recent decision of the United States Supreme Court in the case  
2 of Washington State v. The Confederated Tribes of the Colville  
3 Nation will have a serious adverse economic impact on the Papago  
4 Reservation and poses a serious threat to the economic self-  
5 sufficiency of the Papago Tribe.


6 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
7 support the actions of other Indian Tribes and of the National  
8 Congress of American Indians in seeking appropriate legislation,  
9 and does hereby urge Congress to enact legislation which would  
10 grant Indian Tribes exclusive power to tax all property and  
11 transactions within the boundaries of Indian Reservations.

12 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
13 day of October, 1980, at a meeting at which a quorum was present with a vote  
14 of 965 for; 0 against; 0 not voting; and 1 absent, pursuant  
15 to the authority vested in the Papago Council by Section 2 (a) and (f) of  
16 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
amended, ratified by the Papago Tribe on December 12, 1936, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject  
to review by the Secretary of the Interior and is effective as of the date of  
its enactment by the Papago Council.
