

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Establishing the OEDP Committee)

RES. NO. 105-80

1 WHEREAS, the Papago Council did by Resolution No. 39-76 appoint an Overall  
2 Economic Development Program (OEDP) Committee charged with making  
3 recommendations to the Papago Council for establishing the economic  
4 development program priorities for the Papago Reservation; and  
5 WHEREAS, the Papago Council has decided to reorganize the OEDP Committee and  
6 to expand its functions, purposes and responsibilities.

7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
8 establish the Overall Economic Development Program Committee, which  
9 shall consist of the Vice Chairman of the Papago Council and of one  
10 representative, or alternate, from each of the 11 Districts of the  
11 Papago Reservation. The Vice Chairman shall act as Chairman of the  
12 Committee. In his absence the Committee may appoint another member  
13 of the Committee to act as temporary Chairman. Representatives and  
14 alternates of the Committee shall be appointed by their respective  
15 District Councils for indefinite terms and until replaced by their  
16 respective Councils. In the event a District representative cannot  
17 attend a meeting of the Committee, his or her alternate shall attend.  
18 In the event a representative fails to attend three (3) consecutive  
19 meetings of the Committee, he or she shall be deemed removed and the  
20 alternate shall take such representative's place, and the District  
21 Council of such representative shall designate a successor alternate.  
22 A quorum of the Committee shall exist when three (3) or more Districts  
23 are represented by the representatives or alternates at a meeting of  
24 the Committee. Actions of the Committee shall be by a vote of a  
25 majority of representatives, or alternates present at a meeting of  
26 the Committee at which a quorum is present.

27 The functions, purposes and responsibilities of the Committee shall  
28 be as follows:

- 29 1. To assist in the development of an Overall Economic Develop-  
30 ment Plan for the Papago Tribe in consultation with the  
31 various Districts and Departments of the Papago Tribe, and  
32 to report its findings and recommendations to the Papago  
Council for review and the establishment of objectives and  
priorities of an Overall Economic Development Plan for the  
Papago Tribe.

1 The Committee shall review existing objectives and priorities  
 2 on an ongoing basis and in light of changing needs and avail-  
 3 able resources, and shall report its findings and recommenda-  
 4 tions at least annually and in time to meet the reporting  
 5 dates set by the Economic Development Administration of the  
 6 Department of Commerce, and by other funding or financing  
 7 agencies, in order to secure the finances necessary to fund  
 the projects described in the Overall Development Plan of  
 the Papago Tribe.

- 8 2. In consultation with the various Departments of Tribal govern-  
 9 ment, to assist in collecting statistics, facts and evidence  
 10 of social and financial needs of the Papago Tribe requiring  
 Congressional funding or action.

11 The Committee shall report its findings and recommendations  
 12 to the Papago Council at least annually and in time for the  
 13 Council to develop, complete and present appropriate reports  
 and special appropriation requests to Congress.

14 BE IT FURTHER RESOLVED that the Papago Council does hereby appoint the following

15 persons as members of the OEDP Committee, to serve until replaced by  
 16 their respective District Councils, to-wit:

29 The foregoing Resolution was duly enacted by the Papago Council on the 8th  
 30 day of October, 1980, at a meeting at which a quorum was present with a vote  
 of 854.5 for; 41.5 against; 69.0 not voting; and 0 absent, pursuant  
 31 to the authority vested in the Papago Council by Section 2 (e) and (f) of  
 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
 32 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of

1 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
2 review by the Secretary of the Interior and is effective as of the date of  
its enactment by the Papago Council.
