

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Appointment of Chief Judge of Papago Tribal Courts)

RES. NO. 106-80

1 WHEREAS, Section 2 of Chapter I of the Law and Order Code of the Papago Tribe
2 provides that the Papago Tribal Courts shall consist of two regular
3 Judges, and that such Judges "shall be appointed by the Commissioner
4 of Indian Affairs, subject to confirmation by a majority vote of the
5 Papago Council", for a term of two (2) years; and

6 WHEREAS, Lester J. Barajas has tendered his resignation as Chief Judge of the
7 Papago Tribal Courts effective September 12, 1980, and such resignation
8 has been accepted by the Papago Council; and

9 WHEREAS, it is necessary to appoint a Chief Judge to succede Lester J. Barajas;
10 and

11 WHEREAS, Henry Manuel, one of the present Judges, meets all of the qualifica-
12 tions for the position of Chief Judge; and

13 WHEREAS, the Law and Order Committee has recommended that Henry Manuel be
14 appointed to the position of Chief Judge of the Papago Tribal Courts.

15 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
16 designate and confirm the appointment of Henry Manuel as Chief Judge
17 of the Papago Tribal Courts for a term of two (2) years from the date
18 of appointment, and requests that the Commissioner of Indian Affairs
19 appoint its designee to such position.

20 The foregoing Resolution was duly enacted by the Papago Council on the 8th
21 day of October, 1980, at a meeting at which a quorum was present with a vote of
22 540. for; 350.5 against; 74.5 not voting; and 0 absent, pursuant to
23 the authority vested in the Papago Council by Section 2 (e) and (f) and Section
24 3 (b) of Article V of the Constitution and By-laws of the Papago Tribe of
25 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
26 approved by the Secretary of the Interior on January 6, 1937, pursuant to
27 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
28 subject to review by the Secretary of the Interior, and is effective as of the
29 date of its approval by the Superintendent of the Papago Agency.
