

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Urging Completion of San Simon School)

RES. NO. 108-80

1 WHEREAS, by Joint Resolution of the District Councils of the Pisinemo, Gu Vo  
2 and Hickiwan Districts a request was submitted to the Papago Council  
3 requesting, inter alia, that the San Simon School be completed and  
4 that its completion be determined to be a matter of first educational  
5 priority for the Papago Reservation; and

6 WHEREAS, the Papago Council has heard evidence concerning the immediate need  
7 for the completion of the San Simon School and has determined its  
8 completion is a matter of first educational priority for the Papago  
9 Reservation.


10 NOW, THEREFORE, BE IT HEREBY RESOLVED by the Papago Council that it does hereby  
11 determine that the completion of the San Simon School is a matter of  
12 first educational priority for the Papago Reservation.

13 BE IT FURTHER RESOLVED by the Papago Council that it fully supports the  
14 recommendations contained in the Joint Resolution of the Pisinemo,  
15 Gu Vo and Hickiwan Districts which is attached hereto.

16 BE IT FURTHER RESOLVED by the Papago Council that the appropriate officers of  
17 the Papago Council, of the Papago Education Department, of the Sells  
18 Agency and Phoenix Area Office of the Bureau of Indian Affairs, and  
19 of the Department of Interior do everything necessary and appropriate  
20 to facilitate the purposes of this Resolution, and specifically review  
21 and update any existing statistical data and surveys, and obtain,  
22 develop and prepare updated statistical data and information which will  
23 substantiate the urgent need for the immediate completion of the San  
24 Simon School.

25 The foregoing Resolution was duly enacted by the Papago Council on the 8th  
26 day of October, 1980, at a meeting at which a quorum was present with a vote of  
27 965. for; 0 against; 0 not voting; and 0 absent, pursuant to  
28 the authority vested in the Papago Council by Section 2 (d), (e) and (f) of  
29 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
30 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
31 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the  
32 Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review  
by the Secretary of the Interior and is effective as of the date of its  
enactment by the Papago Council.
