

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Five Year Mineral Exploration Program)

RES. NO. 109-80

1 WHEREAS, the Papago Council did by Resolution No. 52-75 approve a five (5)  
2 year mineral exploration program on the Papago Reservation funded  
3 by the Bureau of Indian Affairs and administered by the U. S. Bureau  
4 of Mines and the U. S. Geological Survey; and

5 WHEREAS, the Papago Council has determined that it is to the benefit of the  
6 Papago Tribe that such mineral exploration continue on an ongoing  
7 basis, provided that the consent is first acquired of each District  
8 Council in which any site specific field work is actually carried on.

9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
10 approve and authorize continuing and ongoing mineral exploration,  
11 funded by the Bureau of Indian Affairs and administered by the U. S.  
12 Bureau of Mines and the U. S. Geological Survey under the direction  
13 of the Papago Mining Director and the Papago Mining Committee;  
14 provided, however, that no site specific mineral exploration field  
15 work shall take place in any district of the Papago Reservation  
16 without first obtaining the consent of the District Council in which  
17 such field work is to be carried on; and provided further that all  
18 copies of logs, surveys, assays, information, maps and reports  
19 resulting from such mineral exploration shall become the property of  
20 the Papago Tribe and shall be delivered to and be kept in the Tribe's  
21 Mining Office for use of the proper and authorized officers of the  
22 Papago Tribe.

23 BE IT FURTHER RESOLVED by the Papago Council that it does hereby authorize  
24 the Chairman, or Vice Chairman, and Secretary of the Papago Council  
25 to execute any agreements, contracts or instruments on behalf of  
26 the Papago Tribe which are necessary or incidental to the purposes  
27 of this Resolution and which have been approved by the Papago  
28 Mining Committee.


29 The foregoing Resolution was duly enacted by the Papago Council on the 8th  
30 day of October, 1980, at a meeting at which a quorum was present with a vote  
31 of 914.5 for; 0 against; 50.5 not voting; and 0 absent, pursuant  
32 to the authority vested in the Papago Council by Section 2 (a), (d), (e) and  
(f) of Article V of the Constitution and By-laws of the Papago Tribe of  
Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and  
approved by the Secretary of the Interior on January 6, 1937, pursuant to

1 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
2 not subject to review by the Secretary of the Interior and is effective as  
of the date of its enactment by the Papago Council.
