

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(San Xavier Bicentennial Building)

RES. NO. 111-80

1 WHEREAS, the American Bicentennial Commission granted \$100,000.00 to the
2 Papago Tribe of Arizona in 1976 for construction of a "Bicentennial
3 Plaza" at San Xavier as part of the American Bicentennial Celebration
4 Program that year; and

5 WHEREAS, the Plaza building was successfully completed by the Papago Construc-
6 tion Company in 1977 and placed into operation by the San Xavier
7 District as a community facility and as a commercial enterprise; and

8 WHEREAS, San Xavier District desires to take over the maintenance, repair and
9 operation of this building as well as legal title ownership; and

10 WHEREAS, transfer of title/ownership from tribal to district ownership is
11 traditional in the case of community buildings and will in no way
12 conflict with the intent, regulations and constraints as contained
13 in the original Bicentennial approved grant.

14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the San Xavier
15 District be given title, ownership and direct responsibility for
16 operation, maintenance and repair of the Plaza building; and

17 BE IT FURTHER RESOLVED that the Papago Tribe shall be granted in perpetuity
18 the use of one (1) permanent room or booth within the Plaza at no
19 rental cost to the Tribe for the purpose of merchandising Papago
20 baskets and other products for direct sale to the public. The
21 Papago Tribe shall pay all other expenses connected therewith
22 including, but not limited to, utilities, telephone, janitorial,
23 maintenance, alteration or modification and operational costs. In
24 the event that the Papago Tribe notifies the District that it does
25 not intend to use said room or booth, or for a period of six months
26 the Tribe does not utilize the room or booth, the District shall
27 have the sole right to rent or lease said room or booth and retain
28 all income generated therefrom.


29 The foregoing Resolution was duly enacted by the Papago Council on the 8th
30 day of October, 1980, at a meeting at which a quorum was present with a vote
31 of 816. for; 149. against; 0 not voting; and 0 absent, pursuant
32 to the authority vested in the Papago Council by Section 2 (e) and (f) of
Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to

1 review by the Secretary of the Interior and is effective as of the date of its
2 enactment by the Papago Council.
