1	WHEREAS, Section 2 of Chapter I of the Law and Order Code of the Papago Tribe							
2	provides that the Papago Tribal Courts shall consist of two regular							
3	Judges, and that such Judges "shall be appointed by the Commissioner							
4	of Indian Affairs, subject to confirmation by a majority vote of the							
5	Papago Council", for a term of two years; and							
6	WHEREAS, there is presently appointed only one Judge, and it is necessary to							
7	appoint a second full time Judge; and							
8	WHEREAS, the Personnel Office has advertised the position and there have been							
9	no applications for the position; and							
10	WHEREAS, for Judge, HILDA MANUEL, meets all the qualifications and has been							
11	recommended by the Papago Law & Order Committee to assume the position							
12	of full time Judge of the Papago Tribal Courts for an interim period							
13	of three months in order to permit the Personnel Office to search for,							
14	and advertise the position for a permanent appointment.							
15	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby							
16	designate and confirm the appointment of HILDA MANUEL as full time							
17	Judge of the Papago Tribal Courts for an interim term of three months							
18	from date of appointment, and does request that the Commissioner of							
19	Indian Affairs appoint its designee to such position.							
20	BE IT FURTHER RESOLVED that the Personnel Office is hereby directed to continue							
21	its search and advertisement for the permanent position of full time							
22	Judge to take effect three months from the date of the interim							
23	appointment of HILDA MANUEL to that position.							
24	The foregoing resolution was dury endeted by the fullage council on the <u>our</u>							
25	day of November, 1980, at a meeting at which a quorum was present with a vote of <u>463.5</u> for; <u>38</u> against; <u>463.5</u> not voting; and <u>0</u> absent, pursuant to the authority vested in the Council by Section 2(a) and (e) and 3 (b) and							
26	(f) of Article V of the Constitution and By-laws of the Papago Tribe as amended ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary							
27	of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its							
28	by the Superintendent of the Papago Agency and is subject to review by the Secretary of Interior.
